# StepSkip<sup>™</sup> Human IgA(Immunoglobulin A) ELISA Kit

Cat# E5006

Storage at 2-8°C for six months

#### **INTRODUCTION**

This ELISA kit applies to the in vitro quantitative determination of Human IgA concentrations in serum, plasma, urine, saliva. Please consult technical support for the applicability if other biological fluids need to be tested.

#### **SPECIFICATION**

Sensitivity: 1.19 ng/mL

Detection Range: 6.25-400ng/mL

**Specificity:** This kit recognizes Human IgA in samples. No significant cross-reactivity or interference between Human IgA and analogues was observed.

Repeatability: Coefficient of variation is < 10%

#### **PRINCIPLE of KIT**

This ELISA kit uses the Sandwich-ELISA principle. The micro ELISA plate provided in this kit has been pre-coated with an antibody specific to Human IgA. Samples (or Standards) and biotinylated detection antibody specific for Human IgA are added to the micro ELISA plate wells. Human IgA would combine with the specific antibody. Then Avidin-Horseradish Peroxidase (HRP) conjugate are added successively to each micro plate well and incubated. Free components are washed away. The substrate solution is added to each well. Only those wells that contain Human IgA, biotinylated detection antibody and Avidin-HRP conjugate will appear blue in color. The enzyme-substrate reaction is terminated by the addition of stop solution and the color turns yellow. The optical density (OD) is measured spectrophotometrically at a wavelength of 450  $\pm$  2 nm. The OD value is proportional to the concentration of Human IgA. You can calculate the concentration of Human IgA in the samples by comparing the OD of the samples to the standard curve.

#### **CONTENTS and STORAGE**

An unopened kit can be stored at  $2-8^{\circ}$ C for six months. After test, the unused wells and reagents should be stored according to the table below.

Note: All reagent bottle caps must be tightened to prevent evaporation and microbial pollution. The volume of reagents in partial shipments is a little more than the volume marked on the label, please use accurate measuring equipment instead of directly pouring into the vial(s).

## **OTHER SUPPLIES REQUIRED**

- Microplate reader with 450 nm wavelength filter
- High-precision transfer pipette, EP tubes and disposable pipette tips
- Incubator capable of maintaining  $37^\circ C$
- Deionized or distilled water
- Absorbent paper
- Loading slot for Wash Buffer

## <u>NOTE</u>

- 1. Please wear lab coats, eye protection and latex gloves for protection. Please perform the experiment following the national security protocols of biological laboratories, especially when detecting blood samples or other bodily fluids.
- 2. A freshly opened ELISA Plate may appear to have a water-like substance, which is normal and will not have any impact on the experimental results.
- 3. Do not reuse the reconstituted standard, biotinylated detection Ab working solution, concentrated HRP conjugate working solution. The unspent undiluted concentrated biotinylated detection Ab (100×) and other stock solutions should be stored according to the storage conditions in the above table.
- The microplate reader should have a 450 (±10 nm) filter installed and a detector that can detect the wavelength. The optical density should be within 0~3.5.
- 5. Do not mix or use components from other lots.
- Change pipette tips in between adding standards, in between sample additions, and in between reagent additions.
  Also, use separate reservoirs for each reagent.



#### SAMPLE COLLECTION

**Serum:** Allow samples to clot for 2 hours at room temperature or overnight at 2-8°C before centrifugation for 15 min at 1000×g at 2-8°C. Collect the supernatant to carry out the assay. Blood collection tubes should be disposable and be nonendotoxin.

**Plasma:** Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples for 15 min at 1000×g at 2-8°C within 30 min of collection. Collect the supernatant to carry out the assay. Hemolysed samples are not suitable for ELISA assay!

**Urine:** Use a sterile container to collect urine samples. Remove particulates by centrifugation for 15 minutes at 1000×g at 2~8°C.Collect the supernatant to carry out the assay.

**Saliva:** Remove particulates by centrifugation for 10 minutes at 4000×g at 2-8°C. Collect the supernatant to carry out the assay. Recommend to use fresh saliva samples.

#### NOTE for SAMPLE:

- 1. Tubes for blood collection should be disposable and be non-endotoxin. Samples with high hemolysis or much lipid are not suitable for ELISA assay.
- Samples should be assayed within 7 days when stored at 2-8°C, otherwise samples must be divided up and stored at -20°C (≤1 month) or -80°C (≤3 months). Avoid repeated freeze-thaw cycles.Prior to assay, the frozen samples should be slowly thawed and centrifuged to remove precipitates. Bring samples to room temperature and mix gently.
- 3. Please predict the concentration before assaying. If the sample concentration is not within the range of the standard curve, users must determine the optimal sample dilutions for their particular experiments.
- 4. If the sample type is not included in the manual, a preliminary experiment is suggested to verify the validity.
- 5. If a lysis buffer is used to prepare tissue homogenates or cell culture supernatant, there is a possibility of causing a deviation due to the introduced chemical substance.
- 6. Some recombinant protein may not be detected due to a mismatching with the coated antibody or detection antibody.

#### **REAGENT PREPARATION**

- Bring all reagents to room temperature (18~25°C) before use. If the kit will not be used up in one assay, please only take out the necessary strips and reagents for present experiment, and store the remaining strips and reagents at required condition.
- Wash Buffer: Dilute 30mL of Concentrated Wash Buffer with 720mL of deionized or distilled water to prepare 750mL of Wash Buffer. Note: if crystals have formed in the concentrate, warm it in a 40°C water bath and mix it gently until the crystals have completely dissolved.
- 3. Standard working solution: Centrifuge the standard at 10,000×g for 1 min. Add 1.0 mL of Reference Standard &Sample Diluent, let it stand for 10 min and invert it gently several times. After it dissolves fully, mix it thoroughly with a pipette. This reconstitution produces a working solution of 2000pg/mL(or add 1.0mL of Reference Standard &Sample Diluent, let it stand for 1-2 min and then mix it thoroughly with a vortex meter of low speed. Bubbles generated during vortex could be removed by centrifuging at a relatively low speed). Then make serial dilutions as



needed. The recommended dilution gradient is as follows:  $2000 \times 1000 \times 500 \times 250 \times 125 \times 62.5 \times 31.25 \times 0$ pg/mL.

4. HRP Conjugate working solution: Calculate the required amount before the experiment (100μL/well). In preparation, slightly more than calculated should be prepared. Centrifuge the Concentrated HRP Conjugate at 800×g for 1 min, then dilute the 100× Concentrated HRP Conjugate to 1× working solution with HRP Conjugate Diluent.

## ASSAY PROCEDURE

- 1. Add the Standard working solution to the first two columns: Each concentration of the solution is added in duplicate, to one well each, side by side (50  $\mu$ L for each well). Add the samples to the other wells (50  $\mu$ L for each well). Immediately add 50 $\mu$ L of Biotinylated Detection Ab working solution each well. Cover the plate with the sealer provided in the kit. Incubate for 90 min at 37°C .Note: solutions should be added to the bottom of the micro ELISA plate well, avoid touching the inside wall and causing foaming as much as possible.
- Aspirate or decant the solution from each well <sup>1</sup> add 350µL of wash bufferto each well. Soak for 1~2 min and aspirate or decant the solution from each well and pat it dry against clean absorbent paper. Repeat this wash step 3 times. Note: a microplate washercan be used in this step and other wash steps.
- Add 100μL of HRP Conjugate working solution each well. Cover with the Plate sealer. Incubate for 30 min at 37°C.
- 4. Aspirate or decant the solution from each well, repeat the wash process for 5times as conducted in step 2.
- Add 90μL of Substrate Reagentto each well. Cover with a new plate sealer. Incubate for about 15 min at 37°C.
  Protect the plate from light. Note: the reaction time can be shortened or extended according to the actual color change, but not more than 30min.
- 6. Add 50μLof Stop Solutionto each well. Note: adding the stop solution should be done in the same order as the substrate solution.
- 7. Determine the optical density (OD value) of each well at once with a micro-plate reader set to 450 nm.

## **CALCULATION of RESULTS**


Average the duplicate readings for each standard and samples, then subtract the average zero standard optical density. Plot a four-parameter logistic curve on log-log graph paper, with standard concentration on the x-axis and OD values on the y-axis. If the samples have been diluted, the concentration calculated from the standard curve must be multiplied by the dilution factor. If the OD of the sample surpasses the upper limit of the standard curve, you should re-test it with an appropriate dilution. The actual concentration is the calculated concentration multiplied by the dilution factor.



# TYPICAL DATA

As the OD values of the standard curve may vary according to the conditions of the actual assay performance (e.g. operator, pipettingtechnique, washing technique or temperature effects), the operator should establish a standard curve for each test. Typical standard curve and data is provided below for reference only.

## **PRECISION**

Inter-assay Precision (Precision between assays): 3 samples with low, mid range and high level HumanIgAwere tested on 3 different plates, 20 replicates in each plate.

## TROUBLESHOOTING



- 6. Even the same operator might get different results in two separate experiments. In order to get reproducible results, the operation of every step in the assay should be controlled.
- 7. Every kit has strictly passed QC test. However, results from end users might be inconsistent with our data due to some variables such as transportation conditions, different lab equipments, and so on. Intra-assay variance among kits from different batches might arise from the above reasons, too.
- 8. Kits from different manufacturers or other methods for testing the same analyte could bring out inconsistent results, since we haven't compared our products with those from other manufacturers.
